This Privacy Statement applies to any and all content, services, applications, and forms accessible through our primary website, quiz.rep4finlit.org. Throughout this Statement, "our" and "we" refers to REP4®FinLit. 1. The Information REP4®FinLit Collects:

- Information You Provide: You may provide to REP4®FinLit certain demographic information (often called "personally identifiable" information), such as your name, email address, postal mailing address, and telephone numbers. You may provide us with this information if you use certain applications or forms, or otherwise use the features and functionality accessible via our site. For example, you provide content to us when you make program inquiries, apply to attend the university, complete web forms, register for events, or make purchases through our site.
- Cookies and Automatically Collected Information: We automatically collect certain types of data when you use our site. This automatically collected information may include your IP address or other device
